Bike and Pedestrian Trails - Senator Jeff Mullis

- Bill Steiner introduced Jeff Mullis, Chairman of the Senate Transportation Committee
- Senator Mullis discussed the status of Georgia transportation funding and the role of rail banking and rail-trails
- He emphasized that the way to promote rail-trails was to:
 - Talk with your local representatives about your interest in the rail-trails
 - Publicly support rail-trails when opponents write letters and speak against the rail-trails (vocal citizens have a disproportionate effect on policy)

Northwest Georgia Contract – David Kenemer

- The two former RDC budgets have not been officially merged, but are being managed as merged
- Funds are available for all 15 counties for the community-based activities and support to be discussed next

Spring Workshops – Based on Dalton Bike-Ped Plan

- Dalton/Whitfield is scheduled for a bike-ped plan for FY2010
- The spring program will be based on a national planner providing assistance to this plan, with participation/observation by other communities
- This is subject to meetings with Dalton/Whitfield to make these arrangements

Walking Lunches – 10 To Schedule

- BWNWGA provides up to \$500 for promotion, t-shirts, etc. but NO food (GDOT regulations) for the event
- Planning and any food sponsors are the responsibility of the hosting town/organization
- The walk is about 1 mile, followed by lunch
- The intent is to encourage walking at lunch

Trail Map Printing Funding

- Funds (up to \$1,000 usually) are available to help publish maps of walking trails
- The host organization is responsible for all brochure/map development
- The funds are approved after a prototype of the brochure is presented at a BWNWGA meeting
- Requests have been less than the funds available in past years

League of American Bicyclists Cycling Classes

- The class teaches riding technique, road positioning and traffic skills, and bicycle maintenance
- The host is responsible for arranging a location and class promotion, with assistance by the instructor
- The class size is a maximum of 8
- The cost per person is \$25, with a \$25 match by BWNWGA

Winter Speaker Series – Two Biking, Two Hiking

- BWNWGA brought in nationally renown speakers last year as a trial, with an activity followed by a talk
- Based on that experience:

- The speakers will be scheduled for February to early April
- The talks will be in cooperation with another organization to allow more than oneday on-site and a wider public impact
- Suggestions for speakers and cooeprating organizations are needed
 - Rebecca Ryan ("Live First, Work Second") was suggested as a possible speaker

Hosts are needed for all of the above at the November meetings (there are no December meetings)

Bike Route Network

- Brad Kotrba discussed the unused railroad right-of-ways in NW GA
- Sammy Rich talked about the Vann Valley ROW currently being abandoned
- The group voted to support the rail banking of the ROW for potential future use as active Railroads again and for current use as rail-trails
- The group voted to recommend to the NWGARC Board that they publicly support both the Vann Valley preservation via rail banking and a general preservation of regional rail ROW
- The routes for the two former RDC networks have been merged into a single NWGRC bike network
